**STIPULATION AND
CONSENT ORDER**

On this 4th day of April, 2006, the Iowa Board of Dental Examiners and Brenda M. Buenrostro, R.D.A, each hereby agree with the other and stipulate as follows:

The licensee disciplinary hearing scheduled to commence before the Iowa Board of Dental Examiners on the 4th day of April, 2006, shall be resolved without proceeding to hearing, as the parties have agreed to the following Stipulation and Consent Order:

1. That Respondent was issued a registration to practice dental assisting on the 9th day of September, 2003, as evidenced by Registration Number Q08168 which is recorded in the permanent records in the office of the Iowa Board of Dental Examiners.
2. That Iowa Registration Number Q08168 is current and active until June 30, 2007.
3. That the Iowa Board of Dental Examiners has jurisdiction over the parties and subject matter herein.
4. A Notice of Hearing was filed against Respondent on December 15, 2005.

5. The allegations giving rise to the Notice of Hearing are set forth in a document entitled, Statement of Matters Asserted, which is attached to this agreement.

SECTION I.

1. Respondent is hereby **Cited** for failing to follow proper infection control practices and **Warned** that future violations could result in additional disciplinary action.
2. Respondent agrees to successfully pass the dental assistant infection control examination within thirty (30) days of the date of this Order.

SECTION II.

1. Respondent acknowledges that she has read in its entirety the foregoing Stipulation and Consent Order and that she understands its content and that she enters into this Order freely and voluntarily.
2. Respondent agrees this Stipulation and Consent Order constitutes the resolution of a pending contested case. By entering into this Stipulation and Consent Order, the Respondent voluntarily waives any right to a contested case hearing and waives any objections to this Stipulation and Consent Order.
3. Respondent acknowledges that she has the right to be represented by counsel in this matter.
4. Respondent understands that this Order is a public record and is therefore subject to inspection and copying by members of the public.
5. Respondent acknowledges that no member of the Board, nor any employee, nor attorney for the Board, has coerced, intimidated, or pressured her, in any way whatsoever, to execute this Order.

6. Respondent acknowledges that this proposed settlement is subject to approval of a majority of the full Board. If the Board fails to approve this proposed settlement, it shall be of no force or effect to either party.
7. Respondent shall fully and promptly comply with all Orders of the Board and the statutes and rules regulating the practice of dental assisting in Iowa. Any violation of the terms of this Order is grounds for further disciplinary action, upon notice and opportunity for hearing, for failure to comply with an Order of the Board, in accordance with Iowa Code Section 272C.3(2)(a) (2005).
8. The Board's approval of this Stipulation and Consent Order shall constitute a FINAL ORDER of the Board.

This Stipulation and Consent Order is voluntarily submitted on this 31st day of March, 2006.
