COMES NOW the Iowa Dental Board (the Board), and Nicki L. Foreman, R.D.A. (Respondent), on July 16, 2009, and enter into the following Stipulated Registration Agreement.

1. In May 2009, Respondent made application to the Iowa Dental Board for dental assistant registration and qualification in dental radiography.
2. The Board reviewed the registration application and concluded that Respondent had engaged in the following unethical and unprofessional conduct:
 - a) Respondent in her application advised the Board that she had engaged in identity theft/credit card fraud.
 - b) Respondent in her application advised the Board that she had been charged with possession of methamphetamine.

THEREFORE, IT IS HEREBY ORDERED that Respondent's registration shall be placed on probation for a period not to exceed three years. During that time of probation, Respondent shall be subject to the following terms:

PERMANENT RESTRICTIONS

3. Respondent shall disclose this Agreement to all current and future employers who employ her as a dental assistant. Respondent shall report back to the Board with signed statements from all current employers within fourteen (14) days of the date of this Agreement, and thereafter within fourteen (14) days of any new employment relationship, indicating the employer has read and understands this Agreement.

Respondent registration shall be placed on probation for a period not to exceed 3 years.

During the time of probation Respondent shall be subject to the following terms:

4. Respondent agrees to submit to a substance abuse evaluation at a facility prior approved by the Board within forty five (45) days of the receipt of this Order. Respondent will be responsible for any costs associated with this evaluation.
 - a. Respondent shall sign releases to allow for the free flow of information between the Board and Respondent's evaluators, counselors, and aftercare providers.
 - b. Respondent shall immediately comply and document successful compliance with all recommendations of the evaluating/treatment facility.
5. Respondent shall fully cooperate with random unannounced visits by agents of the Board to determine compliance with this Agreement which may include random urinalysis testing.
6. Respondent shall upon reasonable notice, and subject to the waiver provisions of Board rule 650 Iowa Administrative Code 31.6, appear before the Board at the time and place designated by the Board.




7. Respondent acknowledges that she has read in its entirety the foregoing Stipulated Registration Agreement and that she understands its content and that she executed the Agreement freely, voluntarily, and with no mental reservation whatsoever.
8. Respondent acknowledges that she has the right to be represented by counsel in this matter.
9. Respondent understands that this Agreement is a public record and is therefore subject to inspection and copying by members of the public.
10. Respondent acknowledges that no member of the Board, nor any employee, nor attorney for the Board, has coerced, intimidated, or pressured her in any way whatsoever to execute this Agreement.
11. This Registration Agreement is subject to approval of the Board. If the Board fails to approve this Registration Agreement, it shall be of no force or effect to either party.
12. The Board's approval of this Registration Agreement shall constitute a **Final Order** of the Board.
13. Respondent shall fully and promptly comply with all Orders of the Board and the statutes and rules regulating the practice of dental assisting in Iowa. Any violation of this Agreement is grounds for formal disciplinary action, upon notice and opportunity for hearing, for failure to comply with an Order of the Board, in accordance with Iowa Code Section 272C.3(2)(a)(2009).

This Stipulated Registration Agreement is voluntarily submitted on this 10th day of July, 2009.


