
**COMES NOW** the Iowa Dental Board (the Board), and Theresa M. Fury, R.D.H. (Respondent), on September 1, 2011, and enter into the following Stipulated License Agreement.

1. On April 13, 2011, Respondent made application to the Iowa Dental Board for a dental hygiene license.
2. The Board reviewed the dental hygiene license application and concluded that Respondent willfully and repeatedly violated Iowa law between November 2005 and June 2010 by being convicted of possession of alcohol under the legal age on three separate occasions and for supplying alcohol to persons under the legal age twice.
3. The Board has the authority to deny an application for a license or registration on any grounds for which a license may be disciplined. Iowa Code Section 147.4. The Board has authority to discipline a license for violations of the law. Iowa Code Section 153.34(10); 650 Iowa Administrative Code Section 30.4(29).


**THEREFORE IT IS HEREBY ORDERED** that Respondent is hereby **CITED** for violating the provisions of Iowa law and **WARNED** that future conduct of this nature shall be subject to formal disciplinary action by the Board.

4. Respondent acknowledges that she has read in its entirety the foregoing Stipulated License Agreement and that she understands its content and that she executed the Agreement freely and voluntarily.
5. Respondent acknowledges that she has the right to be represented by counsel in this matter.
6. Respondent understands that this Agreement is a public record and is therefore subject to inspection and copying by members of the public.
7. Respondent acknowledges that no member of the Board, nor any employee, nor attorney for the Board, has coerced, intimidated, or pressured her in any way whatsoever to execute this Agreement.
8. This License Agreement is subject to approval of the Board. If the Board fails to approve this License Agreement, it shall be of no force or effect to either party.
9. The Board's approval of this License Agreement shall constitute a **Final Order** of the Board.
10. Respondent shall fully and promptly comply with all Orders of the Board and the statutes and rules regulating the practice of dental hygiene in Iowa.

This License Agreement is voluntarily submitted on this 15 day of August, 2011.
