COMES NOW the Iowa Dental Board (the Board), and Jessica M. Koster, on June 27th, 2013, enter into the following Stipulated Registration Agreement.

1. On September 19, 2012, the Applicant made application to the Iowa Dental Board for a dental hygiene license.
2. The Board reviewed the application for license and concluded that Respondent has engaged in the following unethical and unprofessional conduct:
 - a. Respondent advised the Board through the application process that she has multiple criminal convictions which include: driving while suspended, minor in possession of alcohol, possession of paraphernalia, possession of controlled substances, and operating a motor vehicle while intoxicated 1st offense. Applicant's criminal charges occurred from 1998 to 2004.
3. Respondent completed all court ordered requirements resulting from her convictions, which included multiple fines, courses, and a jail sentence.
4. Respondent has subsequently submitted for, and completed a substance abuse evaluation at a program approved by the Board. Following that evaluation, the program diagnosed Respondent as alcohol dependent and stated that

Respondent's past actions warranted a period of monitoring by the Board to ensure safe practice.

THEREFORE IT IS HEREBY ORDERED that Respondent's dental hygiene license shall be placed on probation for a period of two (2) years. During that time the Respondent shall be subject to the following terms and conditions:

TERMS AND CONDITIONS


1. Respondent shall completely abstain from the personal use and possession of alcohol and all mood altering substances or drugs in any form unless prescribed by a duly licensed and treating health care provider.
2. Respondent shall participate in the Board's random drug and alcohol screening program. Respondent agrees to submit to testing at the frequency rate determined by the Board. In addition, Respondent shall submit to unannounced random witnessed blood, urine, hair, or breath analysis samples on demand by any agent or designee of the Board. Respondent shall promptly pay all costs associated with all drug and alcohol screenings.
3. Respondent shall participate in aftercare group therapy as recommended by the evaluation center. Respondent shall attend group therapy meetings at a rate of once per week for a period of one year. Respondent shall document compliance with attendance of these meetings. These meetings shall be at Respondent's expense.
4. Respondent shall come under the care of a Board approved therapist. Respondent shall meet with her therapist at a frequency to be determined by the therapist. Respondent shall sign releases to allow the Board to fully

communicate with her therapist. Respondent shall promptly document compliance with any and all recommendations made by this therapist. Care provided by the therapist shall be at Respondent's expense.


5. Respondent shall obtain and work with a local 12-step sponsor and attend meetings of Alcoholics Anonymous or Narcotics Anonymous at a frequency of three (3) meetings per week. Respondent shall document and submit written verification of meetings attendance at these meetings to the Board. Verification of meeting attendance requires the date, time, and location of the meetings along with a signature or initials of another person in attendance accompanied by a phone number at which the person can be reached for verification.
6. Applicant shall fully cooperate with the Board to determine compliance with this Agreement.
7. Applicant acknowledges that she has read in its entirety the foregoing Stipulated License Agreement and that she understands its content and that she executed the Agreement freely and voluntarily.
8. Applicant acknowledges that she has the right to be represented by counsel in this matter.
9. Applicant understands that this Agreement is a public record and is therefore subject to inspection and copying by members of the public.
10. Applicant acknowledges that no member of the Board, nor any employee, or attorney for the Board, has coerced, intimidated, or pressured her in any way whatsoever to execute this Agreement.

11. The Board's approval of this Stipulated License Agreement shall constitute a **Final Order** of the Board.
12. Applicant shall fully and promptly comply with all Orders of the Board and the statutes and rules regulating the practice of dental assisting in Iowa. Any violation of this Agreement is grounds for formal disciplinary action, upon notice and opportunity for hearing, for failure to comply with an Order of the Board, in accordance with Iowa Code Section 272C.3(2)(a)(2013).

This Stipulated Registration Agreement is voluntarily submitted on this 15th day of May, 2013.
