**LICENSURE STIPULATION  
AND CONSENT ORDER**

**COMES NOW** the Iowa Board of Dental Examiners (the Board), and Laura Elizabeth Anderson, D.H. (Respondent), on August 22, 2002, and enter into the following Consent Agreement.

1. In May, 2002, Respondent made application to the Iowa Board of Dental Examiners for an Iowa Dental Hygiene license.
2. The Board reviewed the application and concluded that Respondent had engaged in the following unethical and unprofessional conduct:
  - a) In August of 1993, Respondent removed a box of business checks from her place of employment without the authority of her employer and subsequently wrote approximately twenty (20) checks totaling approximately \$7,398.00.
  - b) Respondent later entered a plea of guilty to Theft in the Second Degree, a Class D felony, in the Iowa District Court for Black Hawk County and was subsequently sentenced to five (5) years of probation with the First Judicial District Department of Corrections, and ordered to pay restitution plus interest.

3. Respondent successfully completed and was discharged from probation and paid all required restitution.

### **ORDER**

4. The Board shall issue Respondent a permanent Iowa Dental Hygiene license under the following terms and conditions, which have been imposed with the Respondent's consent.
5. Respondent is hereby **CITED** for engaging in unethical and unprofessional conduct. Respondent is hereby **WARNED** that evidence of unethical and unprofessional conduct in the future may result in disciplinary action including revocation of her Dental Hygiene license.

### **TERMS AND CONDITIONS**


6. Upon beginning practice in Iowa, Respondent shall provide all present and future employers and employment supervisors at any location where Respondent is employed as a dental hygienist with a copy of this Consent Agreement. All such individuals must provide a signed statement to the Board within ten (10) days of employment indicating he/she has read and understands this information. All such individuals shall agree to contact the Board immediately upon receipt of evidence of unprofessional conduct.
7. This Consent Agreement is subject to recommendation by the Dental Hygiene Committee and approval of the Board. If the Board fails to approve this Consent Agreement, it shall be of no force or effect to either party.
8. The Board's approval of this Consent Agreement shall constitute a **Final Order** of the Board.

9. Respondent shall fully and promptly comply with all Orders of the Board and the statutes and rules regulating the practice of dental hygiene in Iowa. Any violation of this Agreement is grounds for formal disciplinary action, upon notice and opportunity for hearing, for failure to comply with an Order of the Board, in accordance with Iowa Code Section 272C.3(2)(a) (2001).
