**STIPULATION AND
CONSENT ORDER**

On this 10th day of March, 2005, the Iowa Board of Dental Examiners and Joshua S. Brower, D.D.S., each hereby agree with the other and stipulate as follows:

The licensee disciplinary hearing scheduled to commence before the Iowa Board of Dental Examiners on the 13th day of January, 2005, and was continued until the 14th day of April, 2005, on the allegations specified in the Statement of Charges which is attached to the Notice of Hearing dated November 23, 2004, shall be resolved without proceeding to hearing, as the parties have agreed to the following Stipulation and Consent Order:

1. That Respondent was issued a license to practice dentistry on the 5th day of November, 1999, as evidenced by License Number 8023 which is recorded in Book D, Page 74, of the permanent records in the office of the Iowa Board of Dental Examiners.
2. That Iowa Dental License Number 8023 is current and in full force until June 30, 2006.

3. That the Iowa Board of Dental Examiners has jurisdiction over the parties and subject matter herein.
4. A Notice of Hearing and Statement of Charges was filed against Respondent on November 23, 2004.

SECTION I.

1. Respondent is hereby **CITED** for practicing conscious sedation without the required permit, and is hereby **WARNED** that further violations of the laws governing the practice of dentistry in Iowa may result in revocation, suspension or other disciplinary action.
2. Respondent shall within a timeframe approved by the Board, remit a civil penalty in the amount of five thousand dollars (\$5,000.00) to the Iowa Board of Dental Examiners.
3. Respondent shall successfully pass a written jurisprudence examination at a Board approved site. Such examination shall be completed within sixty (60) days of the date of this Order.
4. Respondent agrees not make application for a conscious sedation permit prior to four (4) months from the date of this Order.


SECTION II.

1. Respondent acknowledges that he has read in its entirety the foregoing Stipulation and Consent Order and that he understands its content and that he executed the Order freely and voluntarily.

2. Respondent agrees this Stipulation and Consent Order constitutes the resolution of a pending contested case. By entering into this Stipulation and Consent Order, the Respondent voluntarily waives any right to a contested case hearing on allegations contained in the Statement of Charges, and waives any objections to the terms of this Stipulation and Consent Order.
3. Respondent acknowledges that he has the right to be represented by counsel in this matter.
4. Respondent understands that this Order is a public record and is therefore subject to inspection and copying by members of the public.
5. Respondent understands that the Board is required by Federal law to report this Order to the National Practitioner Data Bank and Healthcare Integrity and Protection Data Bank.
6. Respondent acknowledges that no member of the Board, nor any employee, nor attorney for the Board, has coerced, intimidated, or pressured him, in any way whatsoever, to execute this Order.
7. Respondent acknowledges that this proposed settlement is subject to approval of a majority of the full Board. If the Board fails to approve this proposed settlement, it shall be of no force or effect as to either party.
8. Respondent shall fully and promptly comply with all Orders of the Board and the statutes and rules regulating the practice of dentistry in Iowa. Any violation of the terms of this Order is grounds for further disciplinary action, upon notice and opportunity for hearing, for failure to comply with an Order of the Board, in accordance with Iowa Code Section 272C.3(2)(a) (2003).



9. The Board's approval of this Stipulation and Consent Order shall constitute a FINAL ORDER of the Board.

This Stipulation and Consent Order is voluntarily submitted on this 2nd day of March, 2005.




