On this 10<sup>th</sup> day of May, 2013, the Iowa Dental Board and Angel J. King, R.D.A., each hereby agree as follows:

The licensee disciplinary hearing scheduled before the Iowa Dental Board on May 9, 2013, shall be resolved without proceeding to hearing, as the parties have agreed to the following Settlement Agreement and Final Order:

1. Respondent was issued registration to practice dental assisting on the April 26, 2011, as evidenced by registration number R11015 which is recorded in the permanent records in the office of the Iowa Dental Board.
2. Respondent's Iowa dental registration number R11015 is current and will expire on August 31, 2013.
3. The Iowa Dental Board has jurisdiction over the parties and subject matter herein.
4. A Notice of Hearing and Statement of Charges was filed against Respondent on March 28, 2013.

**SECTION I.**

1. Respondent is hereby **CITED** for failure to comply with a decision of the Board imposing discipline and **WARNED** that future conduct of this nature may result in further formal disciplinary action by the Board.

2. Respondent is hereby assessed a civil penalty in the amount of one hundred dollars (\$100.00) for failure to comply with a decision of the Board. The Board notes that as of the date of this Order, Respondent has submitted two hundred dollars (\$200.00) to the Iowa Dental Board in the form of a cashier's check made payable to Treasurer, State of Iowa, which is to be deposited in the State's general fund. This amount reflects payment of the original \$100.00 civil penalty and the \$100.00 civil penalty assessed in this Order.
3. Respondent shall disclose this Agreement and her Combined Statement of Charges, Settlement Agreement and Final Order dated July 13, 2012, to all current and future employers who employ her as a dental assistant. Respondent shall report back to the Board with signed statements from all current employers within fourteen (14) days of the date of this Agreement, and thereafter within fourteen (14) days of any new employment relationship, indicating the employer has read and understands this Agreement. The Board notes that as of the date of this Order, Respondent has submitted signed statements from all current employers that they have read and understand both Orders.

## **SECTION II.**

1. Respondent acknowledges that she has read in its entirety the foregoing Settlement Agreement and Final Order and that she understands its content and that she executed the Order freely, voluntarily, and with no mental reservation whatsoever.
2. Respondent acknowledges she has a right to a hearing in this matter, and she hereby waives that right.
3. Respondent acknowledges that she has the right to be represented by counsel in this matter.

4. Respondent understands that this Order is a public record and is therefore subject to inspection and copying by members of the public.
5. Respondent understands that the Board will report this Order to the National Practitioner Data Bank and Healthcare Integrity and Protection Data Bank.
6. Respondent acknowledges that no member of the Board, nor any employee, nor attorney for the Board, has coerced, intimidated, or pressured her, in any way whatsoever, to execute this Order.
7. Respondent acknowledges that this proposed settlement is subject to approval of a majority of the full Board. If the Board fails to approve this proposed settlement, it shall be of no force or effect to either party.
8. Respondent shall fully and promptly comply with all Orders of the Board and the statutes and rules regulating the practice of dentistry in Iowa. Any violation of the terms of this Order is grounds for further disciplinary action, upon notice and opportunity for hearing, for failure to comply with an Order of the Board, in accordance with Iowa Code Section 272C.3(2)(a)(2013).
9. The Board's approval of this Settlement Agreement and Final Order shall constitute a FINAL ORDER of the Board.

This Settlement Agreement and Final Order is voluntarily submitted on this 8<sup>th</sup> day of May, 2013.
