NOTICE OF HEARING, SETTLEMENT AGREEMENT AND FINAL ORDER

(combined)

COMES NOW the Iowa Dental Board (the Board), and Andris V. Kirsis, D.D.S. (Respondent), on October 28th, 2009, and pursuant to Iowa Code Sections 17A.10(2) and 272C.3(4), enter into the following combined Notice of Hearing, Settlement Agreement and Final Order.

NOTICE OF HEARING

1. A hearing on this matter will not be held as the Board and Respondent have entered into the following combined Notice of Hearing, Settlement Agreement and Final Order.
2. Respondent was issued license number 08329 to practice dentistry in the state of Iowa on June 29, 2005.
3. Respondent's Iowa dental license is current and will expire on August 31, 2010.

LEGAL AUTHORITY AND JURISDICTION

4. The Board has jurisdiction in this matter pursuant to Iowa Code Chapters 147, 153 and 272C.

SECTIONS OF STATUTES AND RULES INVOLVED

COUNT I

5. Respondent is charged under Iowa Code Section 153.34(4) and 650 Iowa Administrative Code 30.4(22) with employing or permitting an unregistered person to practice dental hygiene.

STATEMENT OF MATTERS ASSERTED

6. Board rules require a person engaged in the practice of dental hygiene to be licensed by the Board pursuant to 650 Iowa Administrative Code Section 10.4(1).
7. Respondent allowed an unlicensed person to perform dental hygiene duties which cannot be legally delegated to that person.

SETTLEMENT AGREEMENT

THEREFORE, the Respondent is hereby **CITED** for employing or permitting an unlicensed person to practice dental hygiene and **WARNED** that future violations could result in additional discipline.

IT IS HEREBY ORDERED THAT:

8. Respondent agrees to remit a civil penalty in the amount of five hundred dollars (500.00) to the Iowa Dental Board within sixty (60) days of the date of this Order.
9. Respondent shall in the future, ensure that all hygienists are duly licensed in the state before allowing them to work.

FINAL ORDER

10. This combined Notice of Hearing, Settlement Agreement and Final Order constitutes the resolution of a contested case proceeding.
11. By entering into this combined Notice of Hearing, Settlement Agreement and Final Order, Respondent voluntarily waives any rights to a contested case hearing and waives any objections to the terms of this Settlement Agreement.
12. Respondent understands that by entering into this combined Notice of Hearing, Settlement Agreement and Final Order, he cannot obtain a copy of the investigative file. Under Section 272C.6(4), a copy of the investigative file may only be provided to a licensee after a Statement of Charges is filed but before the final resolution of those charges.
13. This combined Notice of Hearing, Settlement Agreement and Final Order, is voluntarily submitted by Respondent to the Board for consideration.
14. Respondent acknowledges that he has the right to be represented by counsel in this matter.
15. This combined Notice of Hearing, Settlement Agreement and Final Order becomes public record available for inspection and copying upon execution of this agreement in accordance with the requirements of Iowa Code Chapters 17A, 22 and 272C.
16. Respondent understands that the Board is required by Federal law to report this Order to the National Practitioner Data Bank and Healthcare Integrity and Protection Data Bank.



18. This combined Notice of Hearing, Settlement Agreement and Final Order is subject to approval of the Board. If the Board fails to approve this combined Notice of Hearing, Settlement Agreement and Final Order, it shall be of no force or effect to approval of either party.
19. The Board's approval of this Notice of Hearing, Settlement Agreement and Final Order shall constitute a **Final Order** of the Board.
