STATEMENT OF CHARGES, SETTLEMENT AGREEMENT AND FINAL ORDER

(combined)

COMES NOW the Iowa Dental Board, (the Board), and David W. Kroner, D.D.S. (Respondent), on April 29, 2016, and pursuant to Iowa Code sections 17A.10(2) and 272C.3(4), enter into the following combined Statement of Charges, Settlement Agreement, and Final Order.

NOTICE OF HEARING

1. A hearing on this matter will not be held as the Board and Respondent have entered into the following combined Statement of Charges, Settlement Agreement and Final Order.
2. Respondent was issued license number 07449 to engage in the practice of dentistry on July 1, 1990.
3. Respondent's dental license is active and will expire on August 31, 2016.

LEGAL AUTHORITY AND JURISDICTION

4. The Board has jurisdiction in this matter pursuant to Iowa Code chapters 147, and 272C.

SECTIONS OF STATUTES AND RULES INVOLVED

COUNT I

5. Respondent is charged under Iowa Code section 153.34(4) with willfully or repeatedly violating a Board rule by violating the terms of a recovery contract that he entered into with the Iowa Practitioner Review Committee, in violation of 650 Iowa Administrative Code rule 30.4(27).

STATEMENT OF MATTERS ASSERTED

6. Respondent self-reported to the Iowa Practitioner Review Committee (Committee) on January 21, 2015. He was subsequently diagnosed with alcohol dependence.
7. Respondent signed a recovery contract with the Committee on August 19, 2015.
8. Respondent has not complied with the stipulations of the contract and stated his intentions are to retire effective January 1, 2016.

SETTLEMENT AGREEMENT


9. Upon the Board's approval of this Settlement Agreement and Final Order, Respondent agrees to voluntarily surrender his license to practice dentistry in the state of Iowa and understands that pursuant to 650 Iowa Administrative Code rule 51.34(2) a voluntary surrender, when accepted by the Board, shall have the same force and effect as an order of revocation.

10. This agreement shall constitute Respondent's written statement of intention to surrender his Iowa dental license pursuant to rule 51.34(2) effective April 29, 2016.
11. Respondent shall make proper arrangements for the discontinuance of practice pursuant to 650 Iowa Administrative Code rule 27.10.
12. Respondent shall cease and desist from the practice of dentistry effective April 29, 2016.

FINAL ORDER


13. This combined Statement of Charges, Settlement Agreement and Final Order constitutes the resolution of a contested case proceeding.
14. By entering into this combined Statement of Charges, Settlement Agreement and Final Order, Respondent voluntarily waives any rights to a contested case hearing, and waives any objections to the terms of this Settlement Agreement.
15. Respondent understands that by entering into this Combined Statement of Charges, Settlement Agreement and Final Order, he cannot obtain a copy of the investigative file. Under Iowa Code section 272C.6 (4) a copy of the investigative file may only be provided to a licensee after a Statement of Charges is filed but before final resolution of those charges.
16. This combined Statement of Charges, Settlement Agreement and Final Order, is voluntarily submitted by Respondent to the Board for consideration.
17. Respondent acknowledges that he has the right to be represented by counsel in this matter.

18. This combined Statement of Charges, Settlement Agreement, and Final Order become public records available for inspection and copying upon execution of this agreement in accordance with the requirements of Iowa Code chapters 17A, 22 and 272C.
19. Respondent understands that the Board is required by Federal law to report this Order to the National Practitioner Data Bank.
20. Respondent acknowledges that no member of the Board, nor any employee, nor attorney for the Board, has coerced, intimidated, or pressured him, in any way whatsoever, to execute this Order.
21. This combined Statement of Charges, Settlement Agreement and Final Order, is subject to approval of the Board. If the Board fails to approve this combined Statement of Charges, Settlement Agreement and Final Order, it shall be of no force or effect to either party.
22. The Board's approval of this combined Statement of Charges, Settlement Agreement and Final Order shall constitute a **Final Order** of the Board.
