**STIPULATION AND
CONSENT ORDER**

On this 25th day of August, 2005, the Iowa Board of Dental Examiners and Samuel E. Senti, D.D.S., each hereby agree with the other and stipulate as follows:

The licensee disciplinary hearing scheduled to commence before the Iowa Board of Dental Examiners on the 25th day of August, 2005, on the allegations specified in the Statement of Charges which is attached to the Notice of Hearing dated April 15, 2005, shall be resolved without proceeding to hearing, as the parties have agreed to the following Stipulation and Consent Order:

1. That Respondent was issued a license to practice dentistry on the 1st day of October, 1973, as evidenced by License Number 5942 which is recorded in Book D, Page 2, of the permanent records in the office of the Iowa Board of Dental Examiners.
2. That Iowa Dental License Number 5942 is current and in full force until June 30, 2006.
3. That the Iowa Board of Dental Examiners has jurisdiction over the parties and subject matter herein.
4. A Notice of Hearing and Statement of Charges was filed against Respondent on April 15, 2005.

THEREFORE IT IS HEREBY ORDERED THAT Respondent has retired from the practice of dentistry and agrees not to practice dentistry in the state of Iowa until the Board issues an Order authorizing his return to practice. The terms for Respondent's return to practice shall be determined by the Board.

SECTION I.

1. In the event the Board issues an Order authorizing Respondent's return to practice, the Order shall place Respondent's license on probation subject to additional terms and conditions deemed appropriate at that time.

SECTION II.

1. Respondent acknowledges that he has read in its entirety the foregoing Stipulation and Consent Order and that he understands its content and that he executed the Order freely and voluntarily.
2. Respondent agrees this Stipulation and Consent Order constitutes the resolution of a pending contested case. By entering into this Stipulation and Consent Order, the Respondent voluntarily waives any right to a contested case hearing on allegations contained in the Statement of Charges, and waives any objections to the terms of this Stipulation and Consent Order.
3. Respondent acknowledges that he has the right to be represented by counsel in this matter.
4. Respondent understands that this Order is a public record and is therefore subject to inspection and copying by members of the public.


5. Respondent acknowledges that no member of the Board, nor any employee, nor attorney for the Board, has coerced, intimidated, or pressured him, in any way whatsoever, to execute this Order.
6. Respondent shall upon reasonable notice, and subject to the provisions of Board rule 650 Iowa Administrative Code 31.6, appear before the Board at the time and place designated by the Board.
7. Respondent acknowledges that this proposed settlement is subject to approval of a majority of the full Board. If the Board fails to approve this proposed settlement, it shall be of no force or effect to either party.
8. Respondent shall fully and promptly comply with all Orders of the Board and the statutes and rules regulating the practice of dentistry in Iowa. Any violation of this Order is grounds for further disciplinary action, upon notice and opportunity for hearing, for failure to comply with an Order of the Board, in accordance with Iowa Code Section 272C.3(2)(a) (2005).

This Stipulation and Consent Order is voluntarily submitted on this 2 day of August, 2005.
