COMES NOW the Iowa Dental Board (the Board), and Richard W. Arbuckle, D.D.S. (Respondent), on January 26, 2010, and enter into the following Stipulated Reinstatement Agreement.

1. Respondent was licensed in Iowa on January 11, 1996, and subsequently let his license lapse in June of 1998.
2. In 2000, the Board received information from the AADE that Respondent had been disciplined in the state of Colorado. Respondent failed to report this disciplinary action to the Iowa Dental Board.
3. In May 2004, Respondent made application to the Iowa Dental Board for reinstatement of his dental license. Respondent answered no to a question which asked if his dental license has ever been limited, restricted, warned, censured, placed on probation, suspended, or revoked. Following Board review, Respondent was issued his dental license with a Letter of Warning concerning is failure to report disciplinary action.
4. Respondent allowed his dental license to lapse once again by failing to renew in 2008. His license lapsed in November of 2008.

5. In May 2009, Respondent again made application to the Iowa Dental Board for reinstatement of his dental license. Respondent once again answered no to a question which asked if his dental license has ever been limited, restricted, warned, censured, placed on probation, suspended, or revoked.

THEREFORE, IT IS HEREBY ORDERED that the Board issues this **CITATION** for failing to provide accurate information to the Board on his reinstatement application on two separate occasions and **WARNED** that further violations will result in additional discipline by the Board.

Respondent's Iowa dental license will be reinstated subject to the following terms:

SECTION I.

TERMS

1. Respondent agrees to submit a civil penalty in the amount of one thousand dollars (\$1000.00) to the Iowa Dental Board within sixty (60) days of the date of this Order.
2. Respondent shall successfully pass the Dental Jurisprudence examination prior to practicing dentistry in the state of Iowa.

SECTION II.

ACKNOWLEDGEMENTS

1. Respondent acknowledges that he has read in its entirety the foregoing Stipulated Reinstatement Agreement and that he understands its content and that he executed the Agreement freely, voluntarily, and with no mental reservation whatsoever.
2. Respondent acknowledges that he has the right to be represented by counsel in this matter.
3. Respondent understands that this Agreement is a public record and is therefore subject to inspection and copying by members of the public.

4. Respondent understands that the Board will report this Order to the National Practitioner Data Bank and Healthcare Integrity and Protection Data Bank.
5. Respondent acknowledges that no member of the Board, nor any employee, nor attorney for the Board, has coerced, intimidated, or pressured him in any way whatsoever to execute this Agreement.
6. This Reinstatement Agreement is subject to approval of the Board. If the Board fails to approve this Reinstatement Agreement, it shall be of no force or effect to either party.
7. The Board's approval of this Reinstatement Agreement shall constitute a **Final Order** of the Board.
8. Respondent shall fully and promptly comply with all Orders of the Board and the statutes and rules regulating the practice of dentistry in Iowa. Any violation of this Agreement is grounds for formal disciplinary action, upon notice and opportunity for hearing, for failure to comply with an Order of the Board, in accordance with Iowa Code Section 272C.3(2)(a)(2009).


