COME NOW the Iowa Dental Board ("Board"), and Kayla L. Hewitt, (Applicant"), on this 29th day of April, 2016, and pursuant to Iowa Code section 17A.10 (2015) enter into the following Stipulated Registration Agreement ("Agreement").

1. On September 9, 2015, Applicant submitted an application to the Board for a Dental Assistant registration and Dental Radiography qualification.
2. Applicant has multiple criminal convictions between 2010 and 2015 which include: possession of underage alcohol; three (3) operating a motor vehicle while intoxicated; driving while license is revoked; disorderly conduct; assault causing bodily injury; and theft, 5th degree.
3. Applicant is currently on supervised probation until June 2, 2016 and unsupervised probation until March 18, 2017.
4. The Board has authority to deny an application for registration on any ground for which a registration may be revoked or suspended. See Iowa Code section 147.4.
5. The Board has authority to discipline a registrant for a violation of a law of this state without regard to its designation as either a felony or misdemeanor, which law

relates to the practice of dental assisting. See Iowa Code section 153.34(10).

THEREFORE IT IS HEREBY ORDERED that Applicant's dental assistant registration shall be granted and immediately placed on probation until March 18, 2017, or until her court ordered probation is successfully completed, whichever is later. During the period of probation, Applicant shall be subject to the following terms and conditions:

TERMS AND CONDITIONS


1. Applicant shall remain in full compliance with all of the terms of her court ordered probation. Applicant shall report to the Board any changes in her court ordered probation, within ten (10) days of occurrence.
2. Applicant shall authorize her state probationary officer to provide the Board full and complete documentation and information regarding her compliance with the terms of her probation.
3. Applicant shall disclose this Agreement to all current and future employers who employ her as a dental assistant. Applicant shall report back to the Board with signed statements from all current employers within fourteen (14) days of the date of this Agreement, and thereafter within fourteen (14) days of any new employment relationship, indicating the employer has read and understands this Agreement.
4. Applicant shall disclose any arrests or criminal charges to the Board within ten (10) days of occurrence.
5. Applicant shall provide documentation to the Board showing successful completion of her court ordered probation.
6. Applicant shall fully cooperate with random unannounced visits from agents of the Board to determine compliance with this Agreement.

7. Applicant acknowledges that she has read in its entirety the foregoing Stipulated License Agreement and that she understands its content and that she executed the Agreement freely and voluntarily.
8. Applicant acknowledges that she has the right to be represented by counsel in this matter.
9. Applicant understands that this Agreement is a public record and is therefore subject to inspection and copying by members of the public.
10. Applicant understands that the Board is required by federal law to report this Agreement to the National Practitioner Data Bank.
11. Applicant acknowledges that no member of the Board, nor any employee, or attorney for the Board, has coerced, intimidated, or pressured her in any way whatsoever to execute this Agreement.
12. The Board's approval of this Stipulated Registration Agreement shall constitute a **Final Order** of the Board.
13. Applicant shall fully and promptly comply with all Orders of the Board and the statutes and rules regulating the practice of dental assisting in Iowa. Any violation of this Agreement is grounds for formal disciplinary action, upon notice and opportunity for hearing, for failure to comply with an Order of the Board, in accordance with Iowa Code chapter 272C.3(2)(a).
14. Upon full compliance with the terms and conditions of this Agreement and upon expiration of the probationary period, Applicant shall be granted an unrestricted dental assistant registration.

This Stipulated Registration Agreement is voluntarily submitted on this 18th day
