On this 27th day of October, 2011, the Iowa Dental Board and Jay J. Jensen, D.D.S., each hereby agree with the other and stipulate as follows:

The licensee disciplinary hearing originally scheduled to commence before the Iowa Dental Board on the 13th day of January, 2010, was rescheduled to commence on the 7th day of April, 2010. On March 22, 2010, this matter was continued until further Order of the Board on the allegations specified in the Notice of Hearing and Statement of Charges dated October 28, 2009, shall be resolved without proceeding to hearing, as the parties have agreed to the following Stipulation and Consent Order:

1. That Respondent was issued a license to practice dentistry on the 1st day of July, 1996.
2. That Iowa Dental License Number 7847 is current and in full force until August 31, 2012.
3. That the Iowa Dental Board has jurisdiction over the parties and subject matter herein.
4. A Notice of Hearing and Statement of Charges was filed against Respondent on October 28, 2009.

5. Respondent attended a comprehensive clinical assessment at the College of Dentistry, University of Illinois from April 11-14, 2011. Respondent successfully completed the assessment. The evaluators did not identify any areas of concern regarding Respondent's dental skills.

THEREFORE, IT IS HEREBY ORDERED that Respondent is **CITED** for failing to maintain a satisfactory standard of competency in the practice of dentistry and **WARNED** that further violations will result in additional discipline by the Board.

SECTION I.

TERMS AND CONDITIONS

1. Respondent agrees to permanently restrict his practice of performing complete or major reconstructions of the mouth on patients. Respondent agrees to refer such care to practitioners who have special skills, knowledge and experience in complete mouth reconstruction.
2. Respondent shall, within one hundred eighty (180) days of the date of this Stipulation and Consent Order, submit a civil penalty to the Board office in a single payment in the amount of five thousand dollars (\$5,000.00), payable to Treasurer, State of Iowa, and deposited in the general fund.

SECTION II.

GENERAL PROVISIONS


1. Respondent acknowledges that he has read in its entirety the foregoing Stipulation and Consent Order and that he understands its content and that he enters into this Order freely and voluntarily.
2. Respondent agrees this Stipulation and Consent Order only resolves the pending contested case on the allegations contained in the Notice of Hearing and Statement

of Charges dated October 28, 2009. By entering into this Stipulation and Consent Order, the Respondent voluntarily waives any right to a contested case hearing on the allegations contained in the Notice of Hearing and Statement of Charges, and waives any objections to this Stipulation and Consent Order.

3. Respondent acknowledges that he has the right to be represented by counsel in this matter.
4. Respondent understands that this Order is a public record and is therefore subject to inspection and copying by members of the public.
5. Respondent understands that the Board will report this Order to the National Practitioner Data Bank and Healthcare Integrity and Protection Data Bank.
6. Respondent acknowledges that no member of the Board, nor any employee, nor attorney for the Board, has coerced, intimidated, or pressured him, in any way whatsoever, to execute this Order.
7. Respondent acknowledges that this proposed settlement is subject to approval of a majority of the full Board. If the Board fails to approve this proposed settlement, it shall be of no force or effect to either party.
8. Respondent shall fully and promptly comply with all Orders of the Board and the statutes and rules regulating the practice of dentistry in Iowa. Any violation of the terms of this Order may serve as grounds for further disciplinary action, upon notice and opportunity for hearing, for failure to comply with an Order of the Board, in accordance with Iowa Code Section 272C.3(2)(a) (2011).
9. The Board's approval of this Stipulation and Consent Order shall constitute a **FINAL ORDER** of the Board.

This Stipulation and Consent Order is voluntarily submitted on this 11th day of
