On this 6<sup>th</sup> day of April, 2010, the Iowa Dental Board and Tara N.

McLean, R.D.A., each hereby agree with the other and stipulate as follows:

The licensee disciplinary hearing scheduled to commence before the Iowa Dental Board on the 7th day of April, 2010, on the allegations specified in the Notice of Hearing and Statement of Charges dated January 15, 2010, shall be resolved without proceeding to hearing, as the parties have agreed to the following Stipulation and Consent Order:

1. That Respondent was issued a registration to practice dental assisting on the 4th day of November, 2003, as evidenced by registration number Q08223 which is recorded in the permanent records in the office of the Iowa Dental Board.
2. That Iowa registration number Q08223 lapsed November 13, 2009.
3. That the Iowa Dental Board has jurisdiction over the parties and subject matter herein.
4. A Notice of Hearing and Statement of Charges was filed against Respondent on January 15, 2010.

**THEREFORE IT IS HEREBY ORDERED** that Respondent is hereby **CITED** for this unlawful conduct and **WARNED** that future conduct of this nature shall be subject to formal disciplinary action by the Board.

**SECTION I.**

1. Respondent shall disclose this Agreement to all current and future employers who employ her as a dental assistant. Respondent shall report back to the Board with signed statements from all current employers within fourteen (14) days of the date of this Agreement, and thereafter within fourteen (14) days of any new employment relationship, indicating the employer has read and understands this Agreement.
2. Respondent shall remit to the Board a civil penalty in the amount of two hundred and fifty dollars (\$250.00) within thirty (30) days of the date of this Order.

**SECTION II.**


1. Respondent acknowledges that she has read in its entirety the foregoing Stipulation and Consent Order and that she understands its content and that she executed the Order freely, voluntarily, and with no mental reservation whatsoever.
2. Respondent acknowledges her right to a hearing as provided for by law and waives her right to a hearing in this matter.
3. Respondent acknowledges that she has the right to be represented by counsel in this matter.
4. Respondent understands that this Order is a public record and is therefore subject to inspection and copying by members of the public.
5. Respondent acknowledges that no member of the Board, nor any employee, nor attorney for the Board, has coerced, intimidated, or pressured her, in any way whatsoever, to execute this Order.


6. Respondent acknowledges that this proposed settlement is subject to approval of a majority of the full Board. If the Board fails to approve this proposed settlement, it shall be of no force or effect to either party.
7. Respondent shall fully and promptly comply with all Orders of the Board and the statutes and rules regulating the practice of dentistry in Iowa. Any violation of the terms of this Order is grounds for further disciplinary action, upon notice and opportunity for hearing, for failure to comply with an Order of the Board, in accordance with Iowa Code Section 272C.3(2)(a)(2009).
8. The Board's approval of this Stipulation and Consent Order shall constitute a FINAL ORDER of the Board.

This Stipulation and Consent Order is voluntarily submitted on this 5 day of MARCH, 2010.


