**COMES NOW** the Iowa Dental Board (the Board), and Ashley M. Ruttkay, D.A. on June 27<sup>th</sup>, 2013, enter into the following Stipulated Registration Agreement.

1. On April 11, 2013, the Applicant applied to the Iowa Dental Board for dental assistant registration and radiography qualification.
2. The Board reviewed the application for registration and concluded that Applicant has engaged in the following unethical and unprofessional conduct:
  - a. Applicant advised the Board through the application process that she has been convicted of a class D felony for theft in the second degree. Applicant's conviction occurred in 2009.
3. Applicant completed all court ordered requirements resulting from her convictions, which included restitution, fines, community service, victim's empathy class, and three years of probation.


**THEREFORE** Applicant is hereby **CITED** for this unlawful conduct and **WARNED** that future conduct of this nature may result in formal disciplinary action by the Board.

**FURTHER**, Applicant agrees to the following terms as a condition to issuance of her dental assistant registration and radiography qualification:


1. Applicant shall disclose this Agreement to all current and future employers who employ her as a dental assistant. Applicant shall report back to the Board with signed statements from all current employers within fourteen (14) days of the date of this Agreement, and thereafter within fourteen (14) days of any new employment relationship, indicating the employer has read and understands this Agreement.
2. Applicant shall fully cooperate with the Board to determine compliance with this Agreement.
3. Applicant acknowledges that she has read in its entirety the foregoing Stipulated Registration Agreement and that she understands its content and that she executed the Agreement freely and voluntarily.
4. Applicant acknowledges that she has the right to be represented by counsel in this matter.
5. Applicant understands that this Agreement is a public record and is therefore subject to inspection and copying by members of the public.
6. Applicant acknowledges that no member of the Board, nor any employee, or attorney for the Board, has coerced, intimidated, or pressured her in any way whatsoever to execute this Agreement.
7. The Board's approval of this Stipulated Registration Agreement shall constitute a **Final Order** of the Board.

8. Applicant shall fully and promptly comply with all Orders of the Board and the statutes and rules regulating the practice of dental assisting in Iowa. Any violation of this Agreement is grounds for formal disciplinary action, upon notice and opportunity for hearing, for failure to comply with an Order of the Board, in accordance with Iowa Code Section 272C.3(2)(a)(2013).

This Stipulated Registration Agreement is voluntarily submitted on this 27 day of June, 2013.
