NOW on this 31st day of October, 2013, the Iowa Dental Board ("Board") and Dennis J. Schuller, D.D.S. ("Respondent"), each hereby agree with the other and stipulate as follows:

The Board has received a request from Respondent to voluntarily surrender his Iowa dental license in lieu of further compliance with terms and conditions of probation in the Reinstatement Order dated July 16, 2012.

THEREFORE, IT IS HEREBY ORDERED:

SECTION I.

1. Respondent agrees to surrender his Iowa dental license, effective immediately. Respondent understands that pursuant to 650 Iowa Administrative Code section 51.34, a voluntary surrender, when accepted by the Board, shall have the same force and effect as an order of revocation. This agreement shall constitute Respondent's written statement of intention to surrender his license pursuant to 51.34(2).
2. Respondent may seek reinstatement of his dental license at any time following the date of this Order.

3. At such time Respondent requests reinstatement, the Board shall issue an Order granting or denying the Respondent's application for reinstatement. If Respondent's license is reinstated, the Reinstatement Order shall contain specific terms and conditions, pursuant to 650 Iowa Administrative Code Section 51.34(6).


SECTION II.

1. Respondent acknowledges that he has read in its entirety the foregoing Consent Order and that he understands its content and that he executed the Order freely and voluntarily.
2. Respondent acknowledges that he has the right to be represented by counsel in this matter.
3. Respondent understands that this Order is a public record and is therefore subject to inspection and copying by members of the public.
4. Respondent understands that the Board will report this Order to the National Practitioner Data Bank and Healthcare Integrity and Protection Data Bank.
5. Respondent acknowledges that no member of the Board, nor any employee, nor attorney for the Board, has coerced, intimidated, or pressured him, in any way whatsoever, to execute this Order.
6. Respondent acknowledges that this proposed Consent Order is subject to approval of a majority of the full Board. If the Board fails to approve this proposed Consent Order, it shall be of no force or effect to either party.
7. Respondent shall fully and promptly comply with all Orders of the Board and the statutes and rules regulating the practice of dentistry in Iowa. Any violation of the


terms of this Order is grounds for further disciplinary action, upon notice and opportunity for hearing, for failure to comply with an Order of the Board, in accordance with Iowa Code Section 272C.3(2)(a)(2013).

8. The Board's approval of this Consent Order shall constitute a FINAL ORDER of the Board.
