NOW on this 25th day of January, 2018, the Board considered a written request from Respondent for the Board to modify his June 16, 2016 Decision and Order (“Order”). Respondent is requesting the Board discontinue the requirements that he have a practice monitor for periodontal diagnosis, treatment planning, treatment and record keeping as required on page 22, paragraph B (1-4) of the Order, and a monitor for infection control as required on page 21 of the Order (which incorporates the requirements of the Board’s July 2, 2013 Decision and Order).

1. The June 16, 2016 Order resolved charges filed against Respondent on October 23, 2015, charging Respondent with multiple counts involving Respondent’s care of patients with periodontal disease as well as failure to comply with the Board’s prior Decision and Order of July 2, 2013 which involved concerns over Respondent’s infection control standards in his dental office.

2. The June 16, 2016 Order placed Respondent’s license on indefinite probation and required him to immediately comply with the terms of the July 2, 2013 Order, including obtaining a Board-approved Infection Control Monitor and written monitoring agreement and the submission of written reports by the monitor. The Order

also requires Respondent to have a Practice Monitor for periodontal diagnosis, treatment planning, treatment, and recordkeeping, a practice monitoring plan, and the submission of written reports.


3. Respondent's infection control practice monitor and periodontal practice monitor were approved by the Board on July 22, 2016 and September 2, 2016 respectively. Respondent's practice monitors have each submitted quarterly reports, beginning in October, 2016.

4. In considering Respondent's request, the Board reviewed the June 16, 2016 Order, the July 2, 2013 Decision and Order, and Respondent's probation file.

5. Given that this case involved serious charges surrounding treatment of periodontal patients as well as failure to comply with a prior Board Order regarding infection control concerns, the Board determines that a longer period of time of monitoring, for both infection control and periodontal patients, is appropriate in this case.

THEREFORE, IT IS HEREBY ORDERED that Respondent's request for the Board to modify the June 16, 2016 Decision be **DENIED**.
